

## OPEN CALL FOR PROPOSALS

The Self Government of City of Szolnok announces a call for proposals – for the burden of EEA/ Norwegian Financial Mechanism – for the “Environment-conscious education and the pedagogy of sustainability” projects to be realised in the Territory of Jasz-Nagykun Szolnok County.

### **Eligible applicants:**

Sub-measure 1 (component 1): Individual teachers and other employees professionally concerned with environmental protection issues.

The Fund shall support only sub-projects which will be realised in the Territory of Jasz-Nagykun Szolnok County.

### **Eligible operations**

The Fund supports sub-projects in the field of environment-conscious education and the pedagogy of sustainability:

**1. Training of teachers and employees:** This sub-measure supports the training of teachers and other employees professionally concerned with environmental protection issues in environment conscious education and the pedagogy of sustainability.

### **Total amount available for the open calls:**

Sub-measure 1 – Training of teachers and employees 212,478 Euro

### **Minimum and maximum grant amount per sub project:**

Sub-measure 1:

The minimum grant amount per sub-project is 2,000 EUR, the maximum grant amount is 3,500 EUR per sub-project.

### **Co-financing requirements:**

Grants from the Fund will not exceed the below rates of total eligible sub-project costs:

Sub-measure 1:

- 100 percent for training of individuals.

### **Eligibility of costs:**

Costs are eligible if they are justified, necessary and appropriate, and directly related to the sub-project's planned results and long term effects. Eligibility of costs is determined in the *Detailed Eligibility Provisions – Expenditure*.

### **Eligible costs:**

- costs of trainings;
- costs of course material and special literature

### **Duration of sub-projects**

Maximum duration of sub-projects is 12 months; there is no minimum duration.

### **Deadlines and address of submission:**

The submission of the applications should be done by post only. The applications (filled data sheet + enclosures) should be provided in 3 copies (1 original + 2 copies) with continuous numbering, in the bound folder, and another 1 copy electronically (on CD only), in the closed package, as registered mail to the following address:

**Deadline of the applications submission on post: 19 November 2009 24 o'clock** (deadline means the time of the postal take over).

On the envelope should be indicated the Applicant's name, address, the name of the grants source: „Environment Funds” and number of the competition component (1 component). The received competition materials a Szolnoki Városfejlesztő Zrt. (Szolnok Town Development Co.Ltd.) handles confidentially.
