**I. Priorities and financial allocation:**

The division of allocation for the Call for Proposals No.1 is indicative and is divided among three priority areas:

Project duration is **12 months**.

Total amount available for the Call for Proposals No. 1 is **M€ 3,1**.  
Maximum financial contribution from the FM is 90%.  
Co-financing of the projects must be at least 10%.

The amount of grant applied cannot be less than **10 000 €**.  
The amount of grant applied cannot be more than **50 000 €**.

Fixed **exchange rate** for the Open Call for Proposals No.1 is set at **1,0 EUR = 28,366 CZK**.

**II. Eligible Applicants for the Grant:**

NGOs registered in the Czech Republic as:

- **civic association** in accordance with the Law No. 83/1990, as amended;
- **public benefit corporation** in accordance with the law No. 3/2002, as amended; or
- **church-based legal entity** in accordance with the law No 3/2002 Coll., on Church and Religious Organizations as amended.
