



**Call for proposals for
Crossborder Partnership Programme
Open call № 3**

The East European Democratic Centre announces an open call for proposals for co-financing international projects with partners carried out in:

A. bilateral partnerships:

- requiring one foreign partner from the EEA EFTA countries (Norway, Iceland, Liechtenstein) or from the Baltic Sea countries (Denmark, Estonia, Finland, Lithuania, Latvia, Sweden, Germany)
- the overall sum to be allocated in Call № 3: 63,500 Euro

B. multilateral partnerships:

- requiring at least two foreign partners including one Eastern neighbour of Poland/ European Union (Ukraine, Belarus, Russian Federation-Kaliningrad District)
- the overall sum to be allocated in Call № 3: 635,908 Euro

The overall amount to be allocated in Call № 3 is: 699,408 Euro

The Programme is addressed to registered Polish non-profit institutions running activity of public benefit in accordance to article 3 of "Law on Public Service Activity and Volunteerism" dated April 24, 2003 (for more details see point 6 *Guide for Applicants*).

The Programme will co-finance up to 90% of the project's eligible costs.
The maximum amount for one project:

- A. bilateral partnerships: 12,700 Euro
- B. multilateral partnerships: 30,500 Euro

The maximum project duration: 9 months. The implementation of the project must be finished no later than 20.12.2010.

Priority sector of the Norwegian Financial Mechanism for the Programme is regional policy and cross-border cooperation.
